- **All funds will be paid directly to the College on behalf of the successful applicant.**

The financial assistance is based on financial need and ability to succeed in the chosen field. The Wallace Community College Foundation Scholarship Committee will review all applications and award the assistance to the applicants who best meet or exceed the criteria. Recipients may be asked to attend Foundation functions, speak to groups about the value of the scholarship, and participate in College and Foundation marketing efforts.
