

## WALLACE COMMUNITY COLLEGE SPARKS FOUNDATION SCHOLARSHIPS

The WCC Sparks Foundation is offering a limited number of scholarships for dual enrollment students. Listed below are the individual scholarships available, the duration of each award, and the special requirements for obtaining and maintaining each scholarship. All scholarships are based on a 2.5 grade point average, unmet financial need, and recommendation from the Scholarship Committee.

**Abbeville Scholars Dual Enrollment Scholarship:** A scholarship will be awarded to cover tuition, fees, and/or books. The scholarship will be awarded to a Wallace Community College (WCC) Sparks Campus dual enrollment student. Recipient will be either a junior or senior enrolled in Abbeville High School or Abbeville Christian Academy. Recipient can take one three-credit hour course in the fall and one -three credit hour course in the spring as long as the student maintains Continuous Eligibility (in accordance to the Continuous Eligibility Policy). Note that Continuous Eligibility Policy states that a student cannot make a "D", "F", or withdraw from a dual enrollment course. Recipient must enroll in an academic course (in the Associate Degree pathway) OR related program (such as Criminal Justice). Applicant must meet the economical disadvantaged criteria such as receiving free/reduced lunch at school or provide verification of financial need of which his or her family taxable income equates to the current 150% of federal guidelines for poverty.

**Barbour Attorneys Scholarship:** A scholarship will be awarded in the amount of tuition and fees to cover one three-hour credit course. The scholarship will be awarded to a Wallace Community College (WCC) Sparks Campus dual enrollment student. Recipients will be either a junior or senior enrolled in either Barbour County or Eufaula City Schools. Recipient can take one three-credit hour course in the fall and one three-credit hour course in the spring as long as the student maintains Continuous Eligibility (in accordance to the Continuous Eligibility Policy). Note that Continuous Eligibility Policy states that a student cannot make a "D", "F", or withdraw from a dual enrollment course. Recipient must enroll in an academic course (in the Associate Degree pathway) OR related program (such as Criminal Justice).

**Humminbird Scholarship:** Two dual enrollment scholarships will be awarded in the amount of tuition and fees to cover two three-credit hour courses, with a preference given to students enrolled in the Applied Engineering Technology program or in the Information Technology program. Scholarships will be awarded to Wallace Community College (WCC) Sparks Campus dual enrollment students. Recipients will be either a junior or senior enrolled in either Barbour County or Eufaula City Schools. Recipient can take two three-credit hour courses in the fall and two three-credit hour courses in the spring as long as the student maintains Continuous Eligibility (in accordance to the Continuous Eligibility Policy). Note that Continuous Eligibility Policy states that a student cannot make a "D", "F", or withdraw from a dual enrollment course.
