#### **How to Submit your Application Packet**

Please refer to the *Practical Nursing Application Packet Check Sheet* on page 4 of this packet for a list of items that must be included in your application packet. All items should be assembled, fastened together, and submitted as one complete packet. #### **Transcripts**

Transcripts from **EVERY** college that you have attended must be included in your application packet. Include a copy of your high school transcript **ONLY** if you are using high school coursework to count toward points. If your official transcripts are on file at Wallace Community College (WCC), you must still attach copies to your application. **WCC Enrollment Services cannot provide you with copies of another school's transcripts**. Unofficial transcripts are acceptable and may be printed from the Internet for most colleges. **If you have attended Wallace Community College (WCC), you must also include a WCC transcript.** WCC unofficial transcripts are acceptable and can be printed from the WCC website www.wallace.edu

NOTE: WCC Enrollment Services has a 72-hour processing time for WCC transcripts.

#### **Minimum Admission Standards**

Minimum admission standards for the Practical Nursing program include the following:

1) Completed WCC admissions application with the status of "Unconditional Admission" or "Conditional Status Cleared." If you are currently enrolled at another college and cannot obtain "unconditional" status, you must submit all transcripts up to the semester in progress to WCC Enrollment Services. A notation of your status should be made on your "Admission Agreement." If you are not enrolled in any courses at WCC for the Spring 2020 semester, you must re-apply to the College at WCC Enrollment Services. NOTE: WCC Enrollment Services has a 72-hour processing time for WCC Admission Agreement Forms.

- Please note that nursing program applicants who have completed a baccalaureate degree or any graduate coursework must also submit official transcripts from every college attended to WCC Enrollment Services.
- Completed Practical Nursing application packet received by 2 p.m. on Friday, May 29, 2020 (CDT). If mailed, the application packet must be postmarked no later than May 29, 2020 (CDT). EXTENDED DEADLINE IS FRIDAY, JUNE 12, 2020, 2:00 P.M. (CDT).
- 3) Minimum GPA of 2.5 on a 4.0 scale based on the following:
  - ◆ For students with undergraduate level credit hours GPA will be computed based on the most recent 24 hours of undergraduate credit hours;
  - For students with 24 or more credit hours at the graduate level GPA will be computed based on the most recent 24 hours of graduate level credit hours undergraduate level credit hours are ignored;
  - ◆ For students with less than 24 hours at the graduate level GPA will be computed based on the most recent 24 hours of <u>undergraduate credit hours</u> graduate credit hours are ignored.
  - Only transcripted hours from colleges accredited by one of the six regionally accrediting agencies (i.e. SACS) will be considered.
  - ◆ High school credits will not be used in calculating GPA except as required in the Early College Enrollment Program.
- 4) Eligibility for ENG 101, MTH 116, and BIO 201.
  - ◆ ENG 101 (English Composition I)
  - ♦ MTH 116 (Mathematical Applications)
  - ♦ BIO 201 (Human Anatomy and Physiology I)
  - Meet the essential functions or technical standards required for nursing. Please refer to "The Alabama Community College System Nursing Programs Essential Functions" on pages 8-9 of this packet.
- 5) Be in good standing with WCC.
- 6) Meet the essential functions or technical standards required for nursing. Please refer to "The Alabama Community College System Nursing Programs Essential Functions" on pages 8-9 of this packet.
- 7) Completion of the ATI Test of Essential Academic Skills, Version Five (**ATI TEAS**®) taken within three years of the application deadline.

Registration and payment for the ATI TEAS® must be completed online through the vendor site. Registration cannot be handled through Testing Services on either campus. Payments cannot be received through the College Business Office. Applicants must create an online account at <a href="https://www.atitesting.com">www.atitesting.com</a> to schedule a date for testing. If testing at a location other than WCC you must transfer your ATI TEAS® score to WCC. ATI assesses a \$27.00 fee to transfer an ATI TEAS® score to a location other than your original test site.

#### **Calculation of Points**

After meeting minimum requirements, applicants are rank-ordered using a 221-point system based on:

- ♦ ATI TEAS® score (150 possible points)
- ◆ Points for selected college courses (i.e., English 101, Math 116 or higher level math) and/or selected high school courses (i.e., Algebra II or higher level math, highest level Biology) (60 possible points)
- ♦ Additional points (11 possible points) for:
  - Students currently enrolled or who have previously completed courses at WCC (including dual enrollment and/or early college admission)
  - Students who have completed a Certified Nursing Assistant program (applicant must provide documentation verifying that they are currently a Certified Nursing Assistant)

#### **Copies**

You are strongly encouraged to make copies of all materials in your packet prior to submission. The Practical Nursing program office will not make copies of any items in your packet for use in reapplying to the Practical Nursing program or in applying to other programs.

#### **Notification**

Applicants will be notified of acceptance status by <a href="email">email</a>. It is imperative that an accurate email address be submitted on this application. All applicants will receive an email regarding their status within 4 to 6 weeks after the application deadline.

# THE ALABAMA COMMUNITY COLLEGE SYSTEM NURSING PROGRAMS ESSENTIAL FUNCTIONS

The Alabama Community College System endorses the Americans' with Disabilities Act. In accordance with College policy, when requested, reasonable accommodations may be provided for individuals with disabilities.

Physical, cognitive, psychomotor, affective, and social abilities are required in unique combinations to provide safe and effective nursing care. The applicant/student must be able to meet the essential functions with or without reasonable accommodations throughout the program of learning. Admission, progression, and graduation are contingent upon one's ability to demonstrate the essential functions delineated for the nursing programs with or without reasonable accommodations. The nursing programs and/or their affiliated clinical agencies may identify additional essential functions. The nursing programs reserve the right to amend the essential functions as deemed necessary.

In order to be admitted and to progress in the nursing program one must possess a functional level of ability to perform the duties required of a nurse. Admission or progression may be denied if a student is unable to demonstrate the essential functions with or without reasonable accommodations.

The essential functions delineated are those deemed necessary by the Alabama Community College System nursing programs. No representation regarding industrial standards is implied. Similarly, any reasonable accommodations made will be determined and applied to the respective nursing program and may vary from reasonable accommodations made by health-care employers.

The essential functions delineated below are necessary for nursing program admission, progression, and graduation and for the provision of safe and effective nursing care. The essential functions include, but are not limited to, the ability to perform the following:

#### 1) Sensory Perception

- a) Visual
  - Observe and discern subtle changes in physical conditions and the environment
  - ii) Visualize different color spectrums and color changes
  - iii) Read fine print in varying levels of light
  - iv) Read for prolonged periods of time
  - v) Read cursive writing
  - vi) Read at varying distances
  - vii) Read data/information displayed on monitors/equipment
- b) Auditory
  - i) Interpret monitoring devices
  - ii) Distinguish muffled sounds heard through a stethoscope
  - iii) Hear and discriminate high and low frequency sounds produced by the body and the environment
  - iv) Effectively hear to communicate with others
- c) Tactile
  - Discern tremors, vibrations, pulses, textures, temperature, shapes, size, location and other physical characteristics
- d) Olfactory
  - Detect body odors and odors in the environment

- 2) Communication/ Interpersonal Relationships
  - Verbally and in writing, engage in a two-way communication and interact effectively with others, from a variety of social, emotional, cultural and intellectual backgrounds
  - b) Work effectively in groups
  - c) Work effectively independently
  - d) Discern and interpret nonverbal communication
  - e) Express one's ideas and feelings clearly
  - f) Communicate with others accurately in a timely manner
  - g) Obtain communications from a computer
- 3) Cognitive/Critical Thinking
  - a) Effectively read, write, and comprehend the English language
  - b) Consistently and dependably engage in the process of critical <u>thinking</u> in order to formulate and implement safe and ethical nursing decisions in a variety of health-care settings
  - Demonstrate satisfactory performance on written examinations, including mathematical computations without a calculator
  - d) Satisfactorily achieve the program objectives

#### 4) Motor Function

- a) Handle small delicate equipment/objects without extraneous movement, contamination, or destruction
- b) Move, position, turn, transfer, assist with lifting, or lift and carry clients without injury to clients, self, or others
- c) Maintain balance from any position
- d) Stand on both legs
- e) Coordinate hand/eye movements
- f) Push/pull heavy objects without injury to client, self, or others
- g) Stand, bend, walk, and/or sit for six to 12 hours in a clinical setting, performing physical activities requiring energy without jeopardizing the safety of the client, self, or others
- h) Walk without a cane, walker, or crutches
- Function with hands free for nursing care and transporting items
- j) Transport self and client without the use of electrical devices
- k) Flex, abduct, and rotate all joints freely
- I) Respond rapidly to emergency situations
- m) Maneuver in small areas
- n) Perform daily care functions for the client
- coordinate fine and gross motor hand movements to provide safe, effective nursing care
- p) Calibrate/use equipment
- q) Execute movement required to provide nursing care in all health-care settings
- r) Perform CPR and physical assessment
- s) Operate a computer

#### 5) Professional Behavior

- a) Convey caring, respect, sensitivity, tact, compassion, empathy, tolerance, and a healthy attitude toward others
- b) Demonstrate a mentally healthy attitude that is age-appropriate in relationship to the client
- c) Handle multiple tasks concurrently
- d) Perform safe, effective nursing care for clients in a caring context
- e) Understand and follow the policies and procedures of the college and clinical agencies
- f) Understand the consequences of violating the student code of conduct
- g) Understand that posing a direct threat to others is unacceptable and subjects one to discipline
- Meet qualifications for licensure by examination as stipulated by the Alabama Board of Nursing
- i) Do not pose a threat to self or others
- Function effectively in situations of uncertainty and stress inherent in providing nursing care
- k) Adapt to changing environments and situations
- 1) Remain free of chemical dependency
- m) Report promptly to clinicals and remain for six to 12 hours on the clinical unit
- n) Provide nursing care in an appropriate time frame
- Accepts responsibility, accountability, and ownership of one's actions
- Seek supervision/consultation in a timely manner
- q) Examine and modify one's own behavior when it interferes with nursing care or learning

Upon admission, an individual who discloses a disability can request reasonable accommodations. Individuals will be asked to provide documentation of the disability in order to assist with the provision of appropriate reasonable accommodations. The respective college will provide reasonable accommodations but is not required to substantially alter the requirements or nature of the program or provide accommodations that inflict an undue burden on the respective college. In order to be admitted, one must be able to perform all of the essential functions with or without reasonable accommodations. If an individual's health changes during the program of learning so that the essential functions cannot be met with or without reasonable accommodations, the student will be withdrawn from the nursing program. The nursing faculty reserves the right at any time to require an additional medical examination at the student's expense in order to assist with the evaluation of the student's ability to perform the essential functions.
