#### **Income Tax Season Is Coming**

After Christmas Season comes Income Tax Season. Many students are working and earning money for the first time. They have probably noticed that not all the money they earn makes it into their pockets. Uncle Sam and the state get part of it before they ever see their check. But sometimes some of that money may come back in the form of a tax refund.

Students need to know: Do I need to file a federal tax return?

> Can I deduct tuition and fees? Is my scholarship taxable?

What tax records do I need to keep and for how long?

Can I file on line?

I filed a federal income tax return, where is my refund?

### **Money Actions**

Many people have trouble managing their money. They almost always have more month than money—their money runs out before they get their next paycheck.

Most people would rather just not think about money. That is a sure way to lose what you earn and get into debt. Like time, money must be thought about and planned.

Any money manager or credit advisor will tell you the same basics:

Live within your means-even if that means changing the way you live.

Live on what you earn. Don't get into debt.

Pay your bills on time-late fees add up, fast!

Paying your bills late also negatively affects your credit score.

Try to save 10% of your earnings each pay period.

It is never too early to prepare for the future-a house, a car, retirement.

Have an Emergency Fund for unexpected expenses-a car repair, medical bill, etc.

Life happens, try to be ready.

Track your expenses-know what you really spend--don't guess.

Make a budget. Does your money = your bills? See what you can cut out.

Be careful of debt-particularly credit card debt-never pay just the minimum.

You will **never** pay off a credit card balance paying the minimum.

Pay off credit card debt as quickly as possible-a good rule is to not charge more than you can pay that month. See above.

Know and manage your FICO (credit) score.

The FICO score is what everyone you want to do business with will look at to see if you are a good risk-employers, real estate agents, insurance agents, lenders, and car dealers.
