# Wallace Community College-Dothan (WCCD) Cares Act Advance Student Funds Disbursement Plan April 30, 2020 (Revised per updated Guidance)

Students impacted by financial challenges and instructional disruption due to the COVID-19 pandemic will receive direct financial support from Wallace Community College-Dothan (WCCD) as a benefit of federal *CARES Act* funding signed into law on March 27, 2020.

The CARES Act provides institutions with significant discretion on how to award this emergency assistance to students. In accordance with federal and state guidance, WCCD will disburse Cares Act funding to assist all eligible students offset attendance-related costs such as food, housing, course materials, technology, health care, and child care.

The College has identified **2870 eligible Spring Semester 2020 students**. Eligible students have been identified using DOE guidance and the ACCS guidance provided in the April 22, 2020 ACCS MEMO 2020-EXE-033 Amended.

**All certified eligible students** will receive a direct payment of **\$585.00** by May 25, 2020, which is 30 days after the College signed the Department of Education (DOE) certification agreement.

The College is using the universal disbursement method to offer aid to all eligible students to offset attendance-related costs. The disbursement method and amount were determined using the method and minimum technology amount suggested in the April 14, 2020 ACCS MEMO 2020-EXE-033 of \$300.00, with an additional \$285.00 included to offset other costs.

Once the plan is approved by ACCS, the College will begin disbursing these payments, totaling **\$1,677,879**. Disbursement will be by checks mailed to students' home addresses or by direct deposit and will occur in two initial phases.

<u>Phase 1</u>: The College will disperse *CARES Act* aid to the **1833 eligible Pell Grant recipients** enrolled Spring Semester 2020. (\$585.00)

<u>Phase 2</u>: The College **has identified an additional 1037** Spring Semester 2020 students who have not completed a FAFSA but meet Title IV eligibility requirements. These students will certify eligibility using the included form, which will be emailed to students to be completed electronically. Selective service will be verified by logging into <a href="https://www.sss.gov/verify">www.sss.gov/verify</a>. Funds will be dispersed following certification. (\$585.00)

The College has notified students via email that eligibility must be established to receive *CARES Act* funds. Please see the email sent to WCCD students on April 29, 2020.

The College proposes to use the remaining **\$148,929** of the funding to be distributed, based on need, in a third phase to eligible Spring Semester 2020 students.

<u>Phase 3</u>: The remaining funds will be disbursed using a needs based application process managed through the College's Financial Aid Office. Only eligible Spring Semester 2020 students will be able to apply for aid.

The College expects to disburse all CARES Act aid by July 1, 2020.
