

## SACSCOC Policy: Institutional Requirements for Public Disclosure

Standard 8.1 of the Principles of Accreditation and SACSCOC's Policy Statement on Institutional Obligations for Public Disclosure require that accredited institutions identify, evaluate, and publish goals and outcomes for student achievement, appropriate to the institution's mission, the nature of the students it serves, and the kinds of programs offered. It further requires that the institution use multiple measures to document student success. In compliance with Standard 8.1 and SACSCOC policy, the table below provides a statement of Wallace Community College's goals and outcomes for student achievement.
