#### a. CRRSAA (HEERF II) - Spring Semester 2021

The College awarded 1,582 Pell Recipients \$800/student. Non-Pell students received \$600/ student after completing a self-certifying form. We had 936 responses who completed the form for Spring Term 2021. Total awards to students were \$1,827,879.

## b. American Rescue Plan (HEERF III) Summer Term 2021

PELL recipients received \$1,000.00/student. Non-PELL students received \$800/student. In addition, if a student had completed a self-certification form indicating a significant exceptional need, that student received an additional \$200. The College awarded \$2,052,000 to all eligible students for Summer Term 2021, including non-credit students and \$19,600 for the 2nd Mini Term. Total awards to students were \$2,071,600.

## c. American Rescue Plan (HEERF III) Fall Semester 2021

The College awarded **\$4,919,183** to all eligible students for the Fall Term 2021. Each student received **\$353.50**. In addition, PELL recipients got **\$1,000.00/student**. Non-PELL students received **\$800 each**. If a student had a significant exceptional need, that student received an additional **\$200**

b. American Rescue Plan (HEERF III) Student Funds The certification form stated as follows:

Only students who were enrolled in the Spring 2020 semester as of March 16 and are currently enrolled in the Summer 2020 semester are eligible to receive the aid. Unfortunately, Spring 2020 semester dual enrollment students, online students, international, and undocumented students are deemed ineligible. The College will use these criteria for assessing CARES Act disbursements in the summer 2020 term. Therefore, only eligible students who have an expense related to the COVID-19 disruption of campus operations may receive funds from the CARES Act.
